The site also has a grievance mechanism for internal and external stakeholders.</p> <p>The follow up assessment on 8-9 June 2022 confirmed that Legnica has a risk assessment matrix with clearly defined risk mitigation actions and tracking and monitoring systems. The identified human rights risks have been incorporated into the corporate management system software and management reviews are done quarterly.</p>
