Five percent of the time, the hourly operating staff working hours are more than 60 hours per week, which is voluntary.</p> <p>Workers are given 1 day off in 7 as well as annual leave.</p> <p>During the follow up assessment, it was confirmed that the Working Hours and Fatigue Management Policy was issued in July 2022, and was escalated from the initial intended “guidance” to “policy.” The policy was rolled out at the site in July 2022, through communications and training presentations.</p> <p>As a result, the reported average weekly hourly working hours over a 28-day period was under 60 hours for 99.5% of the workers.</p>

There is an instrumentation monitoring system that supports Chino's tailings KPIs</p>

		<p>along with other inspection, monitoring, and oversight activities. The KPIs inform the Early Warning Dashboard reporting process. Through these regular activities, no emergency conditions were triggered. Regular maintenance activities continued with regular and special engineering inspections as appropriate by site tailings engineering and operations team.</p> <p>Chino has undertaken a preliminary semi quantitative risk evaluation as part of a corporate-wide move to implement the Global Industry Standard on Tailings Management (GISTM).</p> <p>Chino is implementing but has not fully implemented the GISTM as required by ICMM member companies.</p> <p>During the follow up assessment, it was confirmed that programme to implement GISTM is progressing at Chino with a completion of full GISTM implementation in 2025. A revised risk assessment in line with GISTM requirements was reported in 2022 and the findings approved by the Independent Tailings Review Board. The conclusion was that all Chino tailings facilities were classified as between 'low' and 'significant' in terms of potential consequence with credible failure mode.</p>

The main pollution risk is particulate emissions, which is managed through a system of monitoring and controls.</p> <p>This was confirmed through interviews with management, review of the risk</p>

		<p>evaluation and risk register entries, review of controls, review of community engagement activities on environmental issues including formal grievances, review of the environmental dashboard, and other document review.</p>

The site regularly evaluates biodiversity as part of the risk register process, which involves identifying, assessing, and mitigating potential adverse impacts to biodiversity and ecosystem services.</p> <p>No World Heritage sites or designated protected areas are impacted by Chino operations.</p>

In interviews, stakeholders remarked on the site's generosity in economic development and philanthropic interests.</p> <p>Chino has initiatives in place to encourage local and regional sourcing as part of the ongoing engagement process.</p> <p>During the follow up assessment, it was verified that the North American Local Procurement Strategy SOP of September 2021 is rolled out at site through training. Entries of local procured goods and services in the system as well as a summary report showing the total payments for local goods and services procured during 2022 confirm that this is fully implemented.</p>

Risks are identified in the risk register and the project risk review.</p> <p>During the follow up assessment, it was verified that the New Mexico Operations launched a "Building Trust with Tribes" team as part of a broader ESG oversight team charged with engaging with local tribes on a range of issues. Evidence of regular meetings, agenda, an engagement on local activities demonstrate the full implementation of the team and corresponding procedures.</p>
